3. Application requirements

The following information is required to be lodged with the application:

- A. Photo proof of identification
- B. ABN details
- C. Certificate of registration on each vehicle being used under this application
- D. Certificate of calibration on flow meter if fitted
- E. Model of backflow prevention valve if fitted
- F. Green slip company
- G. Certificate of vehicle insurance
- H. Heavy vehicle Drivers License number
- I. Names and License of any other nominated drivers
- J. Certificate of public liability insurance
- K. Waste transport vehicle to be fitted with sight tube, flow meter or measurement gauge

REQUIREMENTS: Must be met prior to any acceptance of this application as a condition, vehicle and driver will be authorised to enter upon Council land and entry to Councils waste processing plant to discharge, log and register waste and to abide by conditions of acceptance. Driver must complete all details on waste transport log book and provide copy to Council. Council will be setting the pump out frequency which will appear on business trade waste permit.

NOTE: Council will be charging the **COMPANY** for processing of **SEPTIC** waste and will invoice the company on a monthly basis. Accurate reading of flow meter, gauge or sight tube recording on to log sheet is critical, driver would be held responsible for all readings.

LOG BOOKS: Deemed as Council property, the log books will be in triplicate. The front page shall be white colour and shall be delivered to Narrabri Shire Council Chambers over the counter weekly. Second sheet shall be yellow in colour and shall be retained by the driver for company records. Third sheet shall be green in colour and must remain in the log book. Once log book is completed must be returned to the Council Chambers to Planning and Development Department.

PENALTIES: Under section 143 Protection of the Environment and Operations Act 1997 penalties for transporting waste other than so licensed shall incur such penalties so deemed under the act.

CONTAMINATION OF WASTE: It is an offence to mix waste and contaminate waste as it may adversely affect the potential beneficial reuse of effluent and biosolids.
