The Community Financial

Assistance Grant aims to support local clubs and not-for-profit community organisations to deliver activities, programs, and events that contribute to the economic, infrastructure, social connections, and vibrancy of Narrabri Shire.

Eligibility

- A registered not-for-profit organisation
- An incorporated community group
- Unincorporated community group that has a formal structure, management committee, and bank account
- A community group that is affiliated and has a formal structure, management committee, and bank account
- Registered sporting club that has a management committee with a formal structure, and bank account
- A school P&C or P&F committee
- Partnership arrangement between an eligible entity and a non-eligible entity
- Not for profit childcare facility

Grant preparation and application

- Be an eligible entity located in Narrabri Shire
- Must hold a \$20 million public liability policy
- · Provide quotes and budget
- Provide a project plan
- Have relevant approvals events, DA, road closure, and formal bookings
- Can demonstrate recreational, social, cultural, economic, or environmental benefit to Narrabri Shire or residents
- Show consideration for accessibility, diversity, and inclusion
- Be able to submit an invoice for funds
- Provide a letter of support, social media evidence or community support
- Address the selection criteria in the application
- Provide bank details and financial health
- Willing to acknowledge Council's support through various media options
- Commit to lodging an end-of-project report

Restricted activities and entities

- General running costs, rent, or insurances etc
- Uniforms, accommodation, or travel costs for regional or state representation
- Activities that have commenced before the distribution of funds
- Proposals that have not considered accessibility, diversity, inclusion or do not have regard for Council's Community Strategic Plan
- Individuals or unincorporated groups (ie teams)
- Unincorporated or unaffiliated individuals/ groups
- Groups without formal structures
- Entities that seek to make profit
- Government departments or political parties
- Entities based outside the Shire unless. proposal is beneficial
- Uninsured or without a current certificate of currency
- Entities that have previously breached Council's funding deeds.
- Entities that have received a Council grant previously:
 - ♦ Last two consecutive years (different) projects)
 - Within the same financial year
 - Previous year for same activity
