





## PROFESSIONAL ADVISORY SUPPORT PROGRAM

The Professional Advisory Support Program is funded by Council, under the NSW Government Bushfire Local Economy Recovery program, and provides businesses with up to one hour of free advice in the following categories:

- Accountancy
- Information Technology (IT) Services
- · Website/Digital Marketing

The program is designed to connect local businesses to confidential, professional advice to support them with development, growth, or crisis.

Eligible local small businesses will be able to access up to 1 hour of professional advice at no charge, as part of the program.

To access the Professional Advisory Support Program, local businesses need to complete a short, easy to fill out application to confirm their eligibility. On approval, Council will connect businesses with the professional support they seek

Please note that funding is limited, and Council may not be able to provide support to all eligible businesses (for example, due to high demand).

Access to the Professional Advisory Support Program is subject to applicant eligibility and the availability of Council resources. The Professional Advisory Support Program is part of The Exchange Business Activator Project, funded by the NSW Bushfire Local Economic Recovery Fund.

## Eligibility criteria:

- Business must be located within the Narrabri Shire Council Local Government area.
- Have an active Australian Business Number (ABN).
- In need of immediate critical support to sustain your business.
- Annual turnover less than \$5m.
