AGREEMENT FOR CONSTRUCTION OF AN IRRIGATION PIPELINE/CHANNEL/DRAIN ACROSS A SHIRE ROAD

AGREEMENT

This Agreement is made on _____ (dd/mm/yyyy) between _____ of _____ (hereinafter called the Applicant) on the one part and the Narrabri Shire Council (hereinafter called the Council) of the other part.

The Applicant is the registered proprietor(s) of the land more particularly described in Schedule One of this agreement.

The land or part thereof has a frontage to Shire Road No _____ which is a public road within the Shire of Narrabri.

The Applicant proposes to construct an Irrigation Pipeline/Channel/Drain (herein called the works) and more particularly described in the Drawings and Specifications attached hereto in, on or under a Public Road or Laneway within the Shire of Narrabri in the State of New South Wales, subject to the following conditions and restrictions.

CONDITIONS AND RESTRICTIONS

1. Council sight evidence of public liability insurance for the person or organisation carrying out the work to an amount not less than \$20,000,000.00. This must be in the form of a current Certificate of Currency or a copy of the insurance policy from a recognised Insurance Company or Broker, inclusive of conditions specifically stating the insurance covers work done on Shire Roads.
2. That a copy of location plan plus plans and specification of the proposed structure, giving details of pumping rate, to be forwarded for Council's approval prior to commencement of work. No variations in the above are to be made without resubmission to Council.
3. The whole of the construction and future maintenance of all works within the road reserve shall be to the requirements and satisfaction of Council.
4. The crossing shall be at right angles to the road or as near as possible thereto. The crossing shall be piped for the full width of the road reserve.
5. That where concrete pipes are used for the crossing they are to be of the hydraulic rubber ring joint type.
6. That when P.V.C. pipes are used for the crossing they shall be a minimum of Class 12 pipe.
7. The pipeline shall be laid to a depth to allow a minimum clearance of 600mm between the pipe and the invert of the road table drains.
8. That suitable approved markers be placed on either side of the road adjacent to the works to indicate the location and depth thereof.

CONDITIONS AND RESTRICTIONS CONTINUED

9. That during construction of or repairs to the works, provision for traffic control shall be made and warning signs erected. The applicant shall submit a Section 138 Approval application prior to any maintenance and/or construction works within the road reserve.
10. That the applicant agrees to modify, relocate or remove the works if so required by Council.
11. That Council is indemnified against any claims for loss or damage that may arise through traffic using the road during the progress of construction, maintenance, modification or removal, or any failure of the works or lack of maintenance thereto, in the future.
12. That Council bears no responsibility for any damage the works may suffer at the hands of persons or vehicles using, constructing or maintaining the road.
13. That all necessary work of constructing, maintaining, repairing, modifying or removing the works is to be done at no cost to Council.
14. That where the road reserve is located within a 'Travelling Stock Reserve all works outside the road reserve and within the T.S.R. shall be in accordance with Local Land Services requirements.
15. That a formal agreement be entered into between Council and the applicant covering the conditions of occupancy of the road, such agreement to be prepared by Council, and any costs associated therewith being the responsibility of the applicant.

If the applicant shall commit any breach of the conditions and stipulations contained in this Agreement (such Conditions and Stipulations to be observed or performed) it shall be lawful for the Council immediately thereupon to cancel the permission hereby granted by notice in writing to the applicant.

CERTIFICATION

Nothing in the Agreement shall be construed as:

- a) Conferring upon the Applicant exclusive right or title to the sole use of any part of the road containing the work.
- b) Authorising any nuisance to, or permanent obstruction of, the road or public place.
- c) In any way restricting or limiting the powers of the Council in respect of the road and in particular the Council shall not be prevented by anything herein contained from altering the levels of or widening the road or altering the kerbs, gullies or drains thereof.
